This rule and its exceptions are fully discussed in an excellent annotation of Mr. Bennett to Benjamin on Sales, ed. 1888, 504, 023. The first and general rule relating to warranty in contracts of sale is that the buyer purchases at his own risk--careat emptor--unless the seller either gives an express warranty, or unless a warranty is implied by law, or unless the seller is guilty of a fraudulent representation or concealment (Story, Sales. 401): but the rule caveat emptor never applies to cases of fraud. Shelton, for respondents: If the sale of wheat was by sample, then the only warranty that could be implied from the language used was the warranty that the bulk corresponded with the sample.
